

GRANT APPLICATION



The Rural Communities Trust is based on the “helping hand” concept – helping people to help themselves and is committed to restoring an equality of life to rural communities through funding for services and amenities.

To be eligible to receive a grant, an individual, family or community group must be from a small rural area. The Rural Communities Trust defines rural as a town with a population of less than 2,000 or slightly larger if there is no industry, or a rural district.

Grants normally range from \$250.00 - \$3,000.00 but are variable and are subject to the need and circumstances of the applicant/s. Grants may be made for less than the amount applied for and subject to the balance of project funds being raised through other sources.

The Trust will not:

- *Fund applications for course of study*
- *Fund wages and salaries*
- *Fund the purchase of a vehicle/s*
- *Provide set-up grants*
- *Provide on-going funding*
- *Fund profit-making organisations, businesses or consultants for general purposes*
- *Fund overseas or national travel*
- *Provide funds for costs deemed as general purposes*
- *Provide another grant to the same individual, family or group within three years of being a successful grant recipient.*

Final Grant Round Dates for 2022 are 31 March & 30 September.
